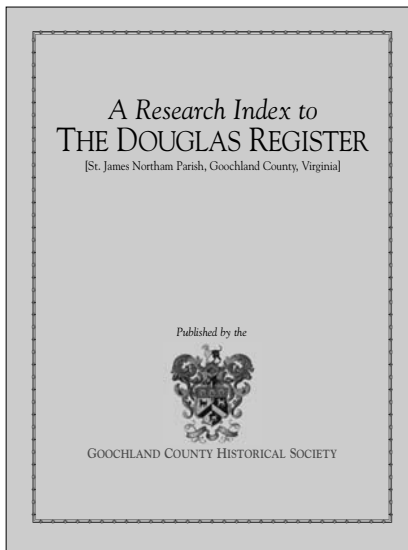

SOCIETY PUBLISHES INDEX TO THE DOUGLAS REGISTER

The newest publication from the Historical Society is *A Research Index to The Douglas Register* (72 pages, 8 1/2" x 11").

The Reverend William Douglas kept a record of all the marriages, births and some deaths that took place in Goochland County from 1750 to 1793 during his service to Saint James Northam Parish. Each section of marriages, births, etc. was listed separately. This very important document to researchers was very difficult to use.

In the summer of 2004, volunteer Fred Sorrell accepted the daunting task of creating an index to *The Douglas Register*. Fred spent hours scanning each page of the most recent edition of the book and then generated an



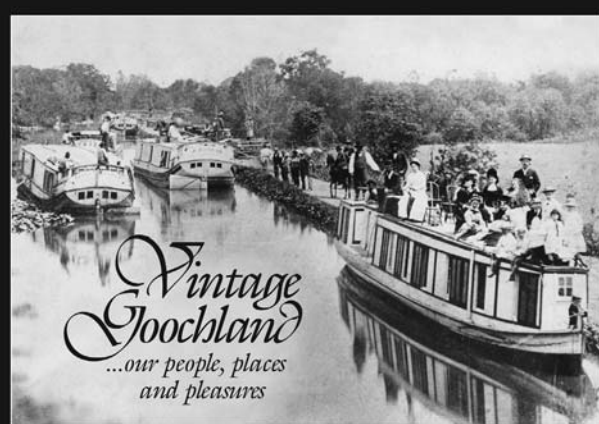
alphabetical listing of all the names. The Index contains more than 2,700 surnames and more than 11,900 individuals. Fred worked with Sharon Perdue and Doug Price to create the Index which was printed commercially. The Society is very grateful to Fred for his efforts to produce this new publication.

SECOND UNION BAPTIST CHURCH HOSTS SPRING MEETING

The Spring Program of the Goochland Historical Society Second Union Church was held at Second Union Baptist Church. Historian Karen Lindermath of Fluvanna spoke about the Rosenwald Schools. Some members of Second Union Church, on Hadensville-Fife Road, came to the Historical Society to ask for help in preserving the school building that sits on Church property. An application was made to have the property designated as a national historic landmark on the National Register of Historic Places. Second Union and the Historical Society are eagerly waiting to hear the decision, which could provide the opportunity to apply for grants to create a black history museum.

As part of the research done by the Historical Society, it was discovered that Lindermath had written her master's thesis on Early Twentieth Century American Capitalist Philanthropy: Julius Rosenwald and the Rural School Building Program. She was invited to speak at the meeting and to our pleasure, she agreed. Mrs. Lindermath gave a fascinating talk and concluded with a question and answer session. Members toured the school building following the meeting.

Sears, Roebuck & Company became a household name when Julius Rosenwald developed their mail-order business. He was also a philanthropist and in 1917, the Rosenwald Foundation was created. Part of the funds from this foundation were used to help build over 5,000 schools in poverty stricken black communities of the rural south, "making the American dream possible for these children". This was not a charity. Money was given in the form of a grant where the community had to raise enough money to match the grant, provide 2 acres of land on which the school would be built, and contribute labor to construct the building. This project resulted from Rosenwald's friendship with Booker T. Washington of Tuskegee Institute, both of whom held strong beliefs about self-reliance. There were six models of school buildings, designed by Tuskegee-trained architects, all which arrived at the sites in pre-fabricated kits.

The Rosenwald School located at Second Union Baptist Church was divided into two sections. Younger students were taught on one side of moveable panels that divided the building and the older students on the other. The original blackboards still hang in the building. The one for the younger students was hung lower on the wall. This building was erected about 1918; in the 1943-44 school year there were 87 students; and the school closed in the mid 1960's. Several people who attended this school shared their memories and answered many questions.

The teachers were strict, and parents reinforced the fact that their children were there to learn. "There wasn't much noise. We were there to learn and the teacher was in charge" said Calvin Hopkins. There was some bus transportation, but most of the children walked to school. "We didn't think anything about walking three or four miles" said William Henson. "We got a good education here."

Archaeological Assessment of Goochland County, Virginia

The College of William & Mary has submitted a draft report of an assessment of archaeological resources in Goochland County. It is designed to serve as the key reference for making decisions about treatment of archaeological sites in the context of land use planning and the development of programs for future surveys. The assessment is the second phase of the architectural

survey project begun in 2002 and was funded by the State Department of Historic Resources, Goochland County Government, and the Goochland County Historical Society. Draft copies of the report are available in the Community Development Office and at the Historical Society.

GCHS Establishes Program for Local Historic Markers

Last April 7th, a committee consisting of Temple Bayliss, Carol Salmon, Sharon Perdue and David and Louise Martin met to discuss how an historical marker program for Goochland could be created. The Historical Society felt that creating a program had merit as there were many venues in Goochland that deserved historical marker designation, but did not qualify for Virginia state historical marker designation. Goochland will be one of the first counties in the Commonwealth to have such a program.

At the first meeting Carol Salmon provided the committee with copies of pictures of various historical marker types from various companies that were traditionally used by other counties, along with the rules for the Henrico County Marker Program. Sharon Perdue volunteered to continue researching various county rules and develop rules for the committee to review at the next meeting. David and Louise Martin volunteered to research the styles, costs, and vendors that provide the best marker option.

At subsequent meetings proposed marker styles and rules were discussed at length. The committee strongly felt that the Goochland County seal should appear on the marker. Prices were considered as well as design and color.

The color scheme agreed upon by the committee was a Black background with White letters. The county seal would have a White background. To see an example of Sewah's South Dakota marker style go to the Sewah Studio website.

At the last meeting, the rules for application were close to being established. The requirements for qualification for a county marker will closely mirror those of the state.

DHR Approves New Goochland County Marker

Although a site has yet to be determined, an historic marker has been approved by the Board of Historic Resources. Listed below is the text that was approved for the marker.

THE 1936 VIRGINIA PRISON RECORDINGS

In 1936 famed folklorist John A. Lomax visited the Virginia State Prison Farm here and at the Virginia State Penitentiary in Richmond. Working for the Library of Congress' Archive of Folk Song, Lomax canvassed southern prisons in search of traditional African American music. On 13 and 14 June 1936, Lomax, assisted by Harold Spivacke, recorded quartets, banjo tunes, work songs, spirituals, and blues at the State Farm. Among the notable performers were inmates Jimmie Strother and Joe Lee. The Library of Congress first released songs from the sessions in the 1940s and they have appeared on many recordings since. These sessions are among the earliest aural records of Virginia's black folk-song tradition.

THOROUGH RESEARCH

The Queen of Spain had received sanction of her title by consent of the Pope, a resident of Rome and ex-officio representative and vice regent of Jesus Christ. Jesus Christ was the son and heir apparent of God. God made Louisiana.

I hope this complies with your request."

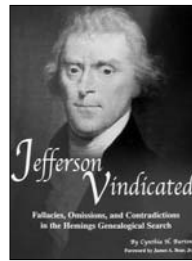

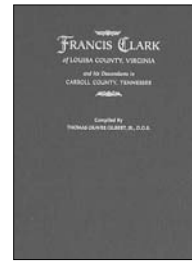

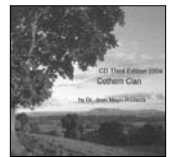

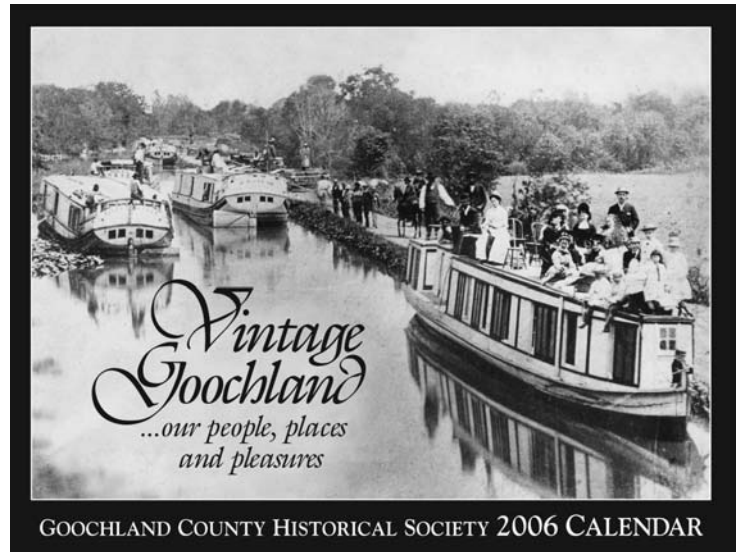

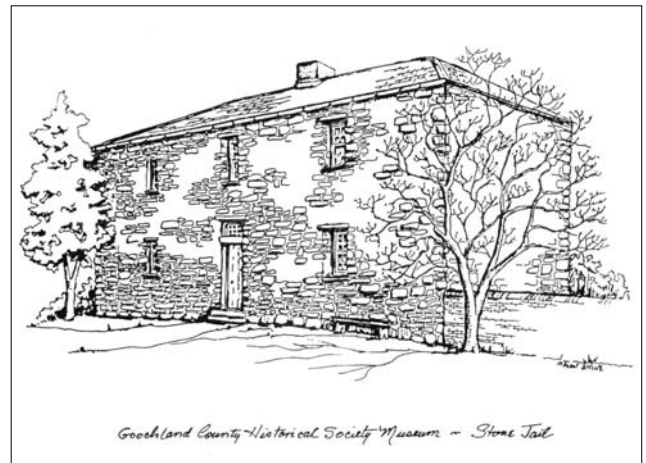

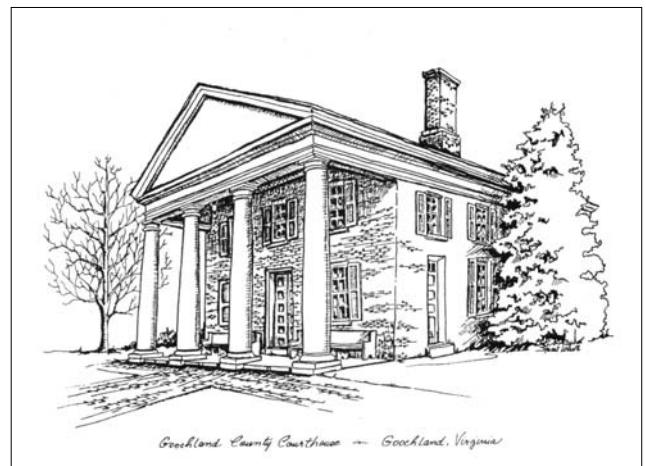

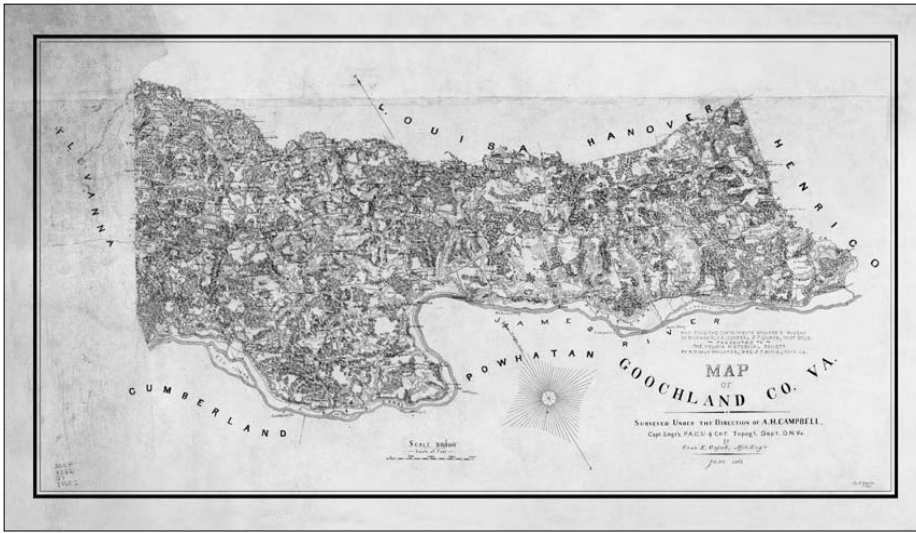

Old Goochland Jail, package of 10 cards and envelopes. \$4.00

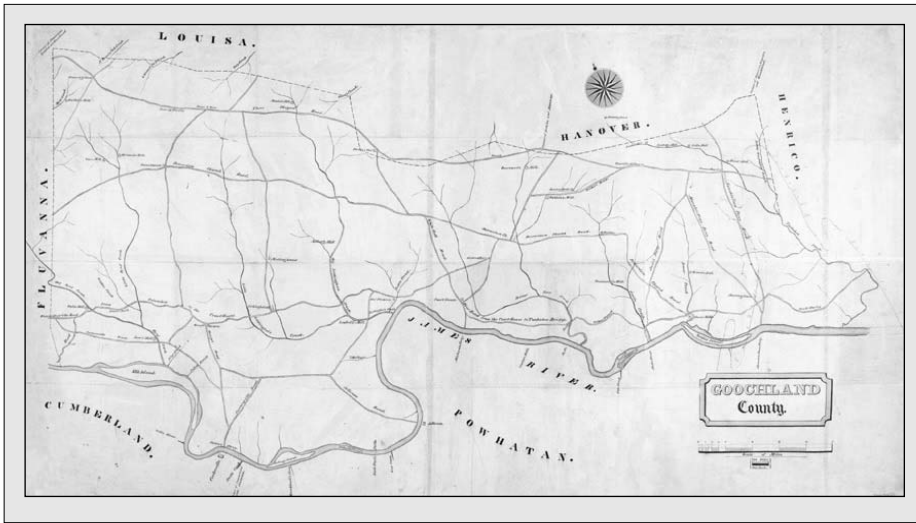

1863 Gilmer Map \$25.00

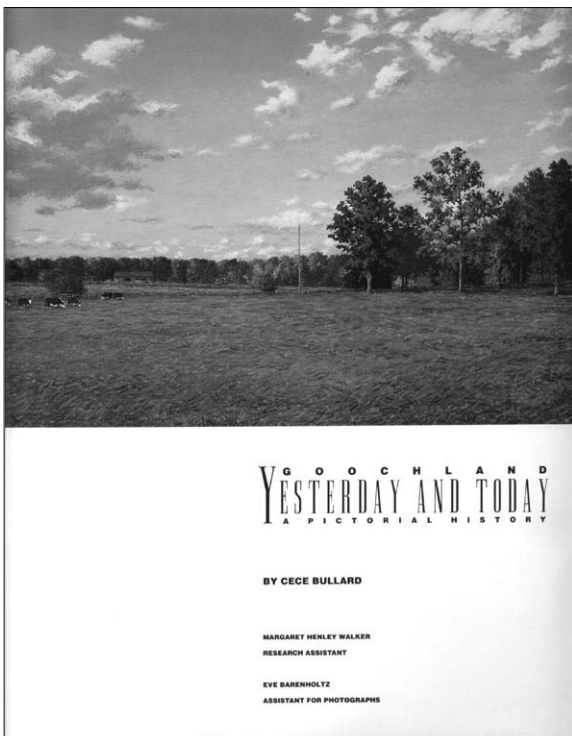
Known as "The Gilmer Map" this map dates to 1863. It is a detailed map which contains the names of land owners, churches, schools, gold mines, and other sites in Goochland County. Reproduced in full color on acid free, heavy weight paper from the Collections of the Virginia Historical Society who gave the Goochland County Historical Society permission to print and sell this map. It measures 32 x 18 inches.

The Historical Society will hold the fall meeting on the lawn and under the trees at the historic home of Lou Preston. The speaker will be Allen Pell Crawford discussing his upcoming book about Thomas Jefferson's retirement years. While still untitled, it is due for publication in the Spring. Members will remember Mr. Crawford from his talk at Tuckahoe Plantation when he discussed his novel *Unwise Passions*.

The event will be held at 'Ben Dover' located on the south side of River Road west (Rt. 6) and west of Hermitage Road (Rt. 676) just across from "The Meadows" development.



BEN DOVER was sold in 1921 to William T. Reed, Sr., who remodeled the house, removing the tower and adding the pedimented front. Mr. Reed used the estate as a rural retreat for hunting and entertaining. Following Mr. Reed's death, Ben Dover eventually became the property of his daughter Alice and her husband, Dr. Robert S. Preston, and in 1960, it became the home of Mr. and Mrs. Robert S. Preston, Jr.
